# The 7 Stages of the Sustainability Standard

## How do I gain the accreditation?



- You will submit relevant documentation for each relevant stage through the POPAI “checkbox” portal. Once you apply for the Sustainability Standard, POPAI will provide you with a guide detailing the requirements.
- POPAI will guide and advise you through the process, ensuring that your submissions are both relevant and robust.
- Once all documents are submitted, they are audited by an independent third-party eco-consultant.

## What does it cost?

**POPAI Members** : £749 + VAT for 12 months

**Non-Members** : £1199 + VAT for 12 months

An initial application fee of £250 will be required with the remaining balance paid prior to becoming accredited. Your 12 month period starts from the date of your application NOT the date of your accreditation. The Sustainability Standard is renewable annually.
